
## Front door for children a risk of harm:

The **Sexual Behaviours Traffic Light Tool** supports professionals working with children and young people by helping them to identify and respond appropriately to sexual behaviours.

The tool uses a traffic light system to categorise the sexual behaviours of young people and is designed to help professionals:

- Make decisions about safeguarding children and young people
- •Assess and respond appropriately to sexual behaviour in children and young people
- •Understand healthy sexual development and distinguish it from harmful behaviour

# **Experienced DSL training**

This one day course is for senior school leadership staff (DSL) who have responsibility for safeguarding children in their school/workplace.

- To provide updates on changes in guidance, legislation and statutory requirements of the roles and responsibilities of a DSL to inform in house school induction and training.
- Enhance the knowledge of the DSL and provide practical guidance on developing and informing local school strategy and policy.
- Assessing need and risk and levels of intervention and how to contribute to local multiagency processes and systems.

## Safer Recruitment Training

Based on an understanding of offender behaviour to:

- Identify the key features of staff recruitment that help deter or prevent the appointment of unsuitable people
- Consider policies and practice that minimise opportunities for abuse or ensure its prompt reporting
- Help participants begin to review their policies and practice in recruitment with a view to creating a safer culture

## **Managing allegations Training**

- To understand national guidance and local procedures for managing allegations against staff, carers and volunteers
- To understand the processes that must be followed when responding to and investigating allegations against a member of staff or volunteer
- Know what to do if you think a member of staff, carer or volunteer has harmed or might pose a risk of harm towards a child or children
- Understand the role of the Named Senior Designated Officer, Senior Manager and Local Authority Designated Officer
