# Working Together to safeguard Children 2018

Working Together has strengthened the safeguarding expectations in the voluntary, charity and, faith-based organisations with an emphasis on 'positions of trust'. Chapter 2 sets out the importance of these organisations having robust safeguarding policies and practices, where paid and voluntary staff know how to recognise risk, how to raise concerns, and how to make referrals to social care services and a stronger focus on identification for early help.



# Information Sharing 2018 Update

This guidance has been updated to reflect the GDPR and Data Protection Act 2018. It is very clear to state this legislation will not prevent, or limit, the sharing of information for the purposes of keeping children and young people safe. You are able to share safeguarding concerns under the Special category personal data.

General Data Protection

# Disqualification by Association 2018

The Department for Education (DfE) has published revised statutory guidance for schools and local authorities, relating to disqualification under the Childcare Act 2006 which came into force on 31 August 2018. The guidance removes disqualification by association for individuals working in childcare in non-domestic settings (e.g. schools and nurseries).

# Inspecting Safeguarding (Ofsted, 2018)

Ofsted has published a new update to Inspecting safeguarding in early years, education and skills taking into account the changes in KCSIE and WT 2018. Schools will need to ensure that these aspects are considered in policies and in the curriculum.

A useful list of all the changes has been made available, but the key changes are:

- not only are staff and volunteers carefully selected and vetted, but 'ongoing suitability' should be considered to prevent the opportunities for harm to pupils
- inspectors will 'consider safeguarding policies and practice and evidence' of staff awareness
- the previous guidelines
   referred to children learning
   'how to keep themselves safe'.
   This phrase has been changed
   to children know how to
   'recognise when they are at
   risk and how to get help when
   they need it'
- schools and colleges hold 'more than one emergency contact number for each pupil or student'

- staff should consider the 'wider environmental factors in a child's life that may be a threat to the safety and/or welfare'
- staff in schools and colleges are supported to make reasonable judgements about when it may be appropriate to use physical contact with a child to protect them from injury
- school leaders, including governors and Designated Safeguarding Leads should understand the arrangements in their local area during the transition from LSCBs to the new local safeguarding partnerships
- prohibition checks are not normally required for teaching assistants, unless they have a QTS or undertake teaching work
