3. Update re Head of Service	<p>Michael Jarrett introduced himself to the meeting as Service Lead, Early Years and Development . He is looking forward to working in Slough and ensuring there is the infra structure in place to enable Early Years to meet the challenge of the regeneration and new buildings in Slough that will attract new families.</p> <p>The FIS and SEND team have re-joined SBC from the Slough Children's Trust. . The FIS will sit within the Early Years Teams</p>
4. Review Terms of Reference	<p>Terms of Reference reviewed and will be reviewed on an annual basis every Autumn.</p> <p>Membership includes representation by JCP – they do have a duty under working together to work in partnership with Children's Centres but nationally there have been difficulties due to capacity within JCP – establish who the partnership manager is and invite to future meetings.</p> <p>Under additional membership to include 5 other service partners relevant to the priorities in the area this must become a standing item on the agenda for future meetings.</p> <p>Under Purpose of the Service Partner Network Meeting add:</p> <p>Link all tasks to Early Help Strategy – whilst also ensuring duplication with Early Help Collaborative is avoided. Remove Annual dialogue from list of meetings. With above changes the TOR were agreed.</p>

<p>5. Satellite Libraries Review</p>	<p>Satellite libraries based in Chalvey Community Centre, Vicarage Way and Wexham Road Children's Centres operating since 2011/12 have been subject to a review by an external company commissioned by the Library Service. The libraries based in the Children's Centres are self service, no library staff are based there and are delivered in partnership between Library and Children's Centre staff. Data showed performance was low. Findings from the review are that all satellite sites add value to the service offer, they are all well used but not in the traditional library manner which is why they were showing up as under performing. Many families were observed to read the books together but as the books had not been borrowed they were not counted in library stats. Need to consider ways to informally count numbers, collect case studies and anecdotal evidence. 90% of book borrowing from the satellite libraries relates to children's books. Link to service delivery plan to promote reading and interest in reading at every opportunity. Library and Children's Centre staff are meeting to introduce the recommendations from the review including consideration of joint registrations, increase in EAL reading materials, linking reading material to adult learning and other services taking place in the Children's Centre. .</p>

Parent Focus Groups were carried out jointly with the HV team, the focus was on information methods provided by the HV team including access to Duty HV by Telephone or E mail and potential for a skype support ,other questions related to safety in the home and local neighbourhood. 7. Update from Local Area Collaborative	Local Area Early Help Collaboratives are now introduced to Slough in 4 areas, initial meetings have taken place to determine priorities with an objective of improving the effectiveness of early help support in local areas. The potential is to provide inter agency direction and governance of provisions and services for children and families at a local level. Services should be responsive and flexible to need of families with children initially under 11 years (they will be extended to 0 to 19 as they become more established). To provide a collaborative identity between statutory, private and independent partners that are best placed to address use of resources, taking an evidence based approach and reducing the number of referrals that fail to meet the threshold.
8. Showcase – data/performance	<p>A template will be circulated prior to next meeting to record evidence of impact in each service area. Showcase the data in the Spring term, it will be reported to strategic meetings and reports to Cabinet about the difference we are making to address priorities in each cluster.</p> <p>Future meetings will be paperless, all info will be sent out electronically and shared at the meeting using the smart board.</p>
