Wow what a term!

It has been extremely busy with the successful delivery of the first Safeguarding in Education Conference, which saw a range of speakers bringing together their expertise, knowledge and experiences that provided delegates with a deeper understanding of the challenges in responding to the difficult issues that affect Slough children and young people.

We got a special mention in Andrew Hall's newsletter and in Cate Duffy's update to the LA. Maz's top ten tips helped gain insight into working more effectively with children looked after. I will circulate these separately via email. This bumper packed newsletter with local and national safeguarding updates, consultations, and resources will ensure you kept in the safeguarding loop. Watch out for the Safeguarding Policy guidance document which will assist you with ensuring your school safeguarding policy is inclusive of all requirements.

Safeguarding in Education Conference 2018

Andrew Hall on the conference:

"Just before Easter I was pleased to have been asked to speak at a safeguarding conference. The speaker before me was a 19-year old care leaver, talking about her experiences in the 'looked after' system, particularly from a school perspective. Three things stood out for me from Maz's presentation.

Firstly, she asked why social workers had to wear their ID badae when they come into school, as this identifies her as a 'service user', and she felt that this unfairly labelled her amongst her peers. Perhaps social workers should just have the standard school visitor badge? Secondly, when educational outcomes are so poor for LAC pupils, why are they taken out of lessons for meetings? The third. The importance of at least one good teacher who really believes in the young person, whatever challenges comes along. One person to develop a sound, effective relationship with."

138 delegates attended which, included 98% presentation from Slough schools. 100% of staff felt the day was useful and said it will change their practice back at work. The comments from 'what will you change as a direct result from today' were very focussed around the realignment of how to support children looked after (CLA) and families following on from Maz's presentation:

'Think more about what children (LAC) want'

'Think about what can be done to make school a safer place for students and adults to talk about problems'

'Consider how to manage/ support meeting for CLA'

'Assess risks to children and identify what we are going to do





to reduce risks'



'Listen to the voice of the child, in confidence and privately'

'Be aware of social workers meeting with LAC pupil and change our own support for them'

'Talk to pupils about how they want meetings to be planned'

National updates and resources

Home education: call for evidence

The Department for Education (DfE) has launched a call for evidence on issues connected with elective home education. The call for evidence covers:

- registration of children educated at home
- monitoring of home education provision
- support for home educators.

The background to the consultation considers some of the related issues, for example, the anecdotal evidence that parents of children who are a risk of permanent exclusion are being pressurised by some schools to educate their child at home. Some parents of pupils with SEND are feeling that homeeducation is a better solution than a mainstream school with no support.

The DfE is also seeking comment on draft versions of two DfE guidance documents about elective home education - one for local authorities and the other for parents. The deadline for the consultation is 2 July 2018.

Out-of-school education settings: consultation outcome

The Department for Education (DfE) has published a report following the 2015 call for evidence on proposals for a regulatory system for out-of-school settings in England. The DfE has decided not to pursue the model proposed in the call for evidence but intends to develop further the evidence base for a national approach, including future legislation.

The DfE will work with local authorities to help parents make informed choices when choosing out-of-school settings, so that they can be confident that their child is in a safe learning environment.
