### Background

- Virtual Schools mandatory since 2014
- OFSTED report published February 2016 highly critical of Slough Virtual School
- Virtual School Governing Body established March 2016 to reflect a wide range of stakeholders
- This group has the right to collectively challenge others on their role in education

#### Purpose

- to corporately challenge and hold the Virtual School Headteacher to account
- to aspire for children looked after, ensuring voice of child is evident throughout
- to set policy to develop the Virtual School to meet the needs of our children and young people looked after.
- to discuss the educational experience of being a child in care with Slough through a range of stakeholders
- to review performance measures summarised in the Annual Report
  - The number and quality of Personal Education Plans (PEPs);
  - Finance including the spending of Pupil Premium Plus;
  - The attainment of children looked after compared with their local and national peers, including results at public examinations
  - The progress of children looked after compared with their local and national peers
  - The number of children missing education and 16-18 NEETs
  - o Numbers of children looked after in schools in OFSTED categories
