	<ul> <li>A specific definition from the government; defines vulnerable CYP who have a SW (CIN/CP) and CLA; ECHP and some CYP on edge of services who are awaiting an allocated category such as ECHP assessments for CIN/CP assessments. Schools are undertaking welfare checks on these children on edge of services.</li> <li>Query raised about contacting families of concern – should school make</li> </ul>		
	<ul> <li>contact or will Liz Christie at the Virtual School to make contact? <u>Action:</u></li> <li><u>JM to confirm and feed back.</u></li> <li>Some schools have requested class teachers to call all their children regularly who are not on there vulnerable lists but general contacts with</li> </ul>		
	<ul> <li>families. Some schools are RAG rating children and allocating calls accordingly i.e. who calls e.g. DSL and frequency of call.</li> <li>Julia Heath from SEBDOS offered if schools have children or families they are concerned about, but do not meet the threshold for services, SEBDOS</li> </ul>		
	can become involved. SEBDOS have a specific safeguarding policy for this work. Home start is also offering a befriending service and support to families who are on the edge of services/care.		
	<ul> <li>CLA Anne Bunce is the single point of contact to assist with vulnerable list (1,641) known to SCST and assisting with any blockages and escalation through lockdown period. Letters went out to all parents/carers regarding sending vulnerable CYP to school where they can within national guidelines. SCST have RAG rated CYP on their records but may be different ratings to your internal RAG.</li> <li>If a child fits the definition of vulnerable and there is no reason such as a shielded family member or symptoms to prevent them coming to school. Schools to do their best to encourage the parents to allow them to attend school. Action: Schools to encourage and work with parents to ensure</li> </ul>		
	this happens (in good position and in many CYP lives schools are the strongest protective factor in their lives).		
	<ul> <li>EARLY HELP; Reviewing on processes and protocols for EH &amp; will be circulated with the minutes.</li> <li>Services still available to provide support on FIS; no outreach service Penn Road Children's Centre remains open Monday to Friday 8.45am to 4.15pm as the main hub for Children's Centres. 	• SCST Front Door operating as usual and taking referrals. Referrals down as		





	expected due to school closures. Referrals received are predominantly regarding DA and a few concerning children lacking supervision from health. A surge of referrals is expected around online images and peer on peer abuse.	
	SCST are running meetings virtually using Loop. Some inconsistency reported by schools i.e. some taking place virtually and some by phone calls or requests for report updates. ICPCs seem to be via Loop; RCPCs, Strat. Meetings and Core Group meetings seem much less consistent and in some cases Core Groups don't seem to be happening.	
	Schools also reported that Conference Chairs seem unaware that SW reports are not sent out ahead of meetings. DSLs also felt it was difficult to give useful information or make informed decisions without sight of SW reports.	
	Some schools reported concerns about the lack of progress and communication about children of concern/referrals/cases.	
	Action: JM asked for evidence via Egress for details of issues to follow up with the Trust. JM to follow up with SCST and feedback to DSL's	
	KS suggested that the variation might be from hub to hub and a RAG rating might be being used. It was pointed out that it would be useful if schools were made aware of any RAG rating being used and any protocol regarding decisions about whether meetings will be virtual or by telephone or by report update.

Please contact Humza Khalique on thelink@slough.gov.uk Guide attached to minutes.</li> <li>Choices programme, especially Year 6 students who are half way through Kwan's Story. Within the next couple of weeks we will be finalising a version of the resource which students will be able to access virtually. Learners will be able take themselves through a step - by - step process whereby they will, using the story and characters in Kwan's Story. The focus will be transition to Secondary school. The new programme will incorporate well established psychological models that develop young people's ability to reframe the transition process as a growth experience, and to plan and prepare for it in a positive and structured way. The resource will include extension activities whereby parents/carers/ family members and in some cases peers/friend can get involved in discussions, and should schools return at some point during the virtual programme's delivery it will also have enough flexibility built into it that a teacher could take over the delivery at any point. It will effectively 'stand alone' from Part 1 Kwan's Story so will be available to all Slough Primary Schools regardless of whether they have engaged in The Choices Programme to date.</li> <li>Proposal is for monthly DSL Network meetings at the moment – agreed.</li> </ul>
