



This newsletter contains the essential information practitioners in the voluntary and statutory sectors need about the latest local safeguarding partnership developments.





A new "Advancing safeguarding practice group" has been created and is working on the final stages of the neglect strategy, the threshold document and revising the Multi-agency referral form.

New pathways are being created by the Safeguarding Children from exploitation Group so that we can provide a rapid and robust multi-agency response to children who are getting involved in knife crime and/or county lines or being exploited.

An exciting new early intervention tool is being tested out. (Children's Well Being tool) Rooted in the un convention on the rights of the child, the tool helps parents to work out how they are doing in providing for their children's basic needs and helps them to identify the gaps and seek help if they need it.

New pathways for child exploitation in development

The Safeguarding Children from Exploitation Group (SCEG) co-ordinates the work of partners in tackling the exploitation of children and is currently working on new multi-agency risk management pathways. These new arrangements will provide a swift and robust multi agency response to children identified as at risk of exploitation and/or getting involved in violent crime, creating a multi-agency risk management plan. This involves agreeing together a holistic understanding of the risk to the child and coming up with a plan to reduce



that risk, working with the child and parents. Carers. The SCEG groups aims to complete this work in March 2021 and launch in April.

New ways of working: Transitional Safeguarding Meetings

It has long been an ongoing issue to determine the most effective ways to ensure that post 18 years of age, young adults at risk of exploitation continue to be safeguarded in to adulthood. Information needs to be shared between services in both a proportionate and timely way so as the young person approaches 18, they receive access to the guidance, information and advice they will need as a young adult.



Slough Children's Services Trust is currently running a pilot for young people transitioning from 17 to 18 years of age who are risk of exploitation. A series of transition meetings have been held to discuss issues faced by each young person, have a shared understanding of risk, and explore viable services for intervention and continued support. The Multi-agency Risk Tool (MART) (LINK IN HERE) which has been used for the last 18 months to manage risk for adults has been a key instrument to ensure the correct questions were discussed, the risk identified, the right people were around the table and achievable actions/ timescales are implemented to transition each young person successfully.

As a result, there have been a succession of successful meetings one of which the trust was able to ensure that the relevant provisions were signposted for a young person to prepare for his housing needs as well as referrals made to Aik Saath and the YES consortium to address NEET support.

Next steps are to continue the transitional meetings, assess what is working well and not so well and ways in which we can remain consistent in improving outcomes for young adults.

Hoarding Protocol and Toolkit for professionals

In partnership with organisations across Slough, a new hoarding protocol and toolkit has been approved by the Health and Social Care Partnership Board. The aim of this document is to provide information and practical guidance to professionals that work with people that hoard.

In recognition that cases are often complex and involve many agencies, the toolkit includes resources as well as an assessment tool to manage risks effectively. It details how professionals can use the multi agency risk tool to mitigate risks and work with colleagues effectively.

Domestic Abuse Virtual Surgery: Discussion Forum

It was recognised that during the first wave of lockdown, which resulted from the Covid-19 pandemic, that practitioners were facing a number of challenges and complex cases in relation to domestic abuse (DA).

It was felt that peer support and discussion in managing these cases would be welcomed. A monthly DA surgery discussion forum has been set up as a safe place to discuss cases which may have a degree of complexity.

Please note that this group does not replace MATAC and MARAC, or other formal processes, referrals, and pathways.

The monthly surgery will be a drop in session where practitioners from across the partnership will be present during a two hour time slot:

Courses currently being offered

Exploitation of Children, Young People and Vulnerable Adults.

24th February 2021 and 23rd March 2021

If you work with children, young people or vulnerable adults and need to recognise or respond to concerns of exploitation, then this course is for you. It covers all aspects of exploitation across all generations including Child Exploitation, Criminal Exploitation, Gangs and Modern Slavery.

Multi agency Risk Tool for Adults who do not access services

25th March 2021

This course is targeted at all practitioners who work with adults at risk, including 17 – 25 year olds transitioning from support from SCST. It provides a multi-agency framework to provide support when safeguarding support is inappropriate or refused. It improves confidence and competence around multi-agency working to share the risk when working with complex and challenging cases.

Core Groups in Children's Safeguarding

17th March and 30th March

This course is for practitioners who work directly with children and families who would attend Child Protection Conferences and/or Core Group. It is relevant for investigators (Police and Social Workers) and referrers. Areas covered include overcoming barriers and challenges to progressing Core Groups.

Future Plans

We plan to continue running virtual bite sized seminars in the next financial year. These will be advertised on our website as soon as they are agreed.



Continuing Professional Development Options

One of our most popular courses in the past has been our **Level 3 "Working Together to Safeguard Children"**. At a recent Safeguarding Learning and Development Forum, it was agreed that we would move to delivering this course via a modular approach where practitioners can choose which aspects of the course they need to learn about or refresh. You will therefore see in next year's offer a number of 2 hour seminars covering all aspects of the "Working Together to Safeguard Children" course. All our courses are at a level 3 and provide 2 hours of Continuing Professional Development. Practitioners will be able to choose how many hours of CPD they wish to book.

It is really important that practitioners take responsibility for their own development; tracking and documenting skills that you develop is key. It is important that you record, review and reflect on what you learn and so simply attending a seminar is not the end of the learning process. It is really important that you reflect on the learning and record your reflection. It is always a good idea to reflect on your learning with your line manager, mentor or a trusted colleague.
