So it's the final term of this academic year with its ever increasing challenges in a rapidly changing environment. We are all seeking new ways of working, delivering and managing safeguarding in a very different environment. Coronavirus (COVID-19) restrictions are gradually being lifted across the UK,

beginning with schools welcoming children back. However things are not yet back to normal and schools still have a lot to consider. Social distancing measures will continue for everyone. Look out for the attendance surgeries to help staff manage and raise any attendance based issues.

The refreshed threshold document for Slough which has been based on the United Nations Convention for the Rights of the Child (UNCRC) will be published shortly. Keep a look out for the promotional emails. Last term saw the delivery of 'Making quality referrals' seminars which were a great success. You are no doubt already aware that, over the last fortnight the website **'Everyone's Invited**' has drawn much publicity for the shocking testimonials from over 10,000 people describing sexual abuse by other young people. As a result, on 31st March, the government announced that they were launching a review into sexual abuse in schools. The government has asked Ofsted to undertake an immediate review of safeguarding policies in state and independent schools. The review will look at the extent and the severity of the issue and ensure schools have appropriate processes in place to allow pupils to report concerns freely, knowing these will be taken seriously and dealt with swiftly and appropriately.

It will make sure there is sufficient guidance on how schools should deal with sexual harassment and violence allegations, and whether the current inspection regimes, in both state and private schools, are strong enough to address concerns and promote the welfare of children.

A new NSPCC helpline has also been set up to provide both children and adults who are potential victims of sexual abuse in schools with the appropriate support and advice. This includes how to contact the police and report crimes if they wish. The helpline will also provide support to parents and professionals too.

There have been a number of local changes from a new LADO. SCST has moved location and been renamed Slough Children First. Early Help colleagues are moving to join Slough Children First colleagues.

SBC is nearing completion of its transformation programme and restructure. Chelsea Barnes will be, in the short to medium term, overseeing the Inclusion and SEND service as well as her current role as Principal Educational Psychologist. Chelsea brings a wealth of experience to the role and I am sure you will welcome her and support her in the times ahead. This will provide some strong ability to the service and allow us to move forward with strategic planning for the inclusion agenda in Slough as a whole.

Slough Children's First move to Observatory House

As you may have already heard, Slough Children's Services Trust has become Slough Children First

With that achieved, now is the time for the next phase of the journey. Following discussions with the Department for Education, it was agreed that from 1 April the Trust will become Slough Children First, a company wholly-owned by Slough Borough Council.

The Trust had worked hard to pull children's services in Slough out of inadequate for the first time in many years and achieving 'requires improvement to be good' in early 2019 was a significant milestone but we all know we want to be better than this.

Thismove will enable Slough Children First and the council to work in closer partnership and help deliver an excellent service to children and young people in Slough.

One change you may have already noticed is that the role of chief executive at Slough Children First and the role of director of children's services at Slough Borough council have been combined. This change has been in place for the last few months with an experienced interim, Eleni Ioannides, brought in to cover the role and effect the changes.

As part of the transition, several elements of children's services, currently with the council, including the Early Help Hub and Family Information Services, and services to assist young people into education and employment, will move to Slough Children First. This will allow a much more holistic approach to services.

As part of our continuing journey to improve our services for children, young people and families in Slough, the **Early Help Hub** will be joining our colleagues in Slough Children's services Trust as we all transition to Slough Children First. We are all very excited about the opportunity to deliver better integrated services for our children and young people with our partners across Slough.

The delivery of services and support to vulnerable children and families from Early Help services will continue, with the following parts of the team joining Slough Children First in the coming months.

- Family Services and Targeted Family Support
- Targeted Youth Support
- ENGAGE CSE Team
- Young Carers
- NEET and RONI service
- Direct links with the Getting Help and Mental Health Support teams will continue.

Peer on Peer Abuse

The website **'Everyone's Invited'** has drawn much publicity for the shocking testimonials from over 10,000 people describing sexual abuse by other young people. As a result, the government announced a review into sexual abuse in schools. The Department for Education has commissioned the NSPCC to launch a new helpline called **Report Abuse in Education**.

The new helpline will provide both children and adults who are potential victims of sexual abuse in schools with the appropriate support and advice. This includes how to contact the police and report crimes if they wish. The helpline will also provide support to parents and professionals too. Operation Hydrant has been set up by the police to respond to these incidents.

Ofsted and Independent Schools Inspectorate (ISI) review of safeguarding policies

Following the launch of the government's investigation into peer-on-peer sexual abuse, Ofsted will undertake an immediate review of safeguarding policies in state and independent schools. The review will look at the extent and the severity of the issue and ensure schools have appropriate processes in place to allow pupils to report concerns freely, knowing these will be taken seriously and dealt with swiftly and appropriately. The review will conclude by end of May 2021.

Ofsted will visit a sample of schools and colleges where cases have been highlighted, with ISI where appropriate, to look at how well safeguarding is working and to discuss the wider issues raised by the evidence. The review will not report on individual schools or cases, but present a picture of good and poor practice across the country.


The review will consider a number of areas, including:

- Whether the safeguarding guidance to schools is strong enough to safeguard children;
- How schools can be further supported to teach the new RSHE curriculum;
- Multi-agency safeguarding arrangements; and
- How well schools and colleges listen to the voices of children when reporting sexual abuse

Education providers have a statutory duty to safeguard and protect children from harm. The statutory guidance **Sexual violence and sexual harassment between children in schools and colleges** outlines advice for schools and colleges on how to prevent and respond to reports of sexual violence and harassment between children. <u>Gov.UK Sexual Harassment & Sexual Violence</u> The guidance is further updated in KCSIE 2020 in Part 5.

Peer on Peer abuse – Next steps

Education providers need a whole school approach to review and reflect on policy and practice within their setting as soon as possible to ensure tackling peer on peer abuse is embedded in the school ethos. What needs to be considered?



2. Update your safeguarding policy with clear responses on how you handle sexual harrassment, sexual assult and ensure it is uplaoded on your website asap.

3. Ensure your staff understand thier part in responding to peer on peer abuse swiftly and appropriately and reporting methods are clear

4. Develop pupil curriculum to ensure they help YP develop healthy and respectful relationships

5. Make sure young people know how to report and feel confident in your response

What questions can help you understand the issues in your school/college?

We want to be part of this conversation and empower all young people to be able to come forward and report all incidents of sexual violence and sexual harassment. To help you understand the extent of the issue within your setting you need to seek transparency in reporting and recording of incidents of sexual assault, rape and sexual harassment you should consider these key points/questions.

- Is peer on peer abuse recognised by staff in your setting? What is the response and how do staff refer such cases?
- 2. What is the pupil's experience? Do pupils feel safe? Do pupils feel if they share concerns that they are dealt with swiftly, consistently and effectively? Are pupils prepared for life in modern society?
- 3. Seek transparency through your data and trends reported. What does your data tell you? Are there any issues / challenges?
- It may be an idea to set up a dedicated task group with SLT, Safeguarding governor and IT colleagues to look in more detail about your school data, trends, and responses to peer on peer abuse cases.
- 5. You may want to write to your pupils' parents about the national picture on peer and peer abuse and offer assurances that this is taken seriously; what you are doing in your school/college and you may wish to share the NSPCC helpline number.

Safeguarding in Education – Guidance updates

GUIDANCE FOR SCHOOLS/OTHER EDUCATION SETTINGS:

Attendance during COVID update:

In response to the pandemic and the current lockdown, the guidance for children's social care services has recently been updated in the following area:

• Shielding for clinically extremely vulnerable (CEV) children.

The updated section can be found below and the full guidance can be found on the <u>Gov.uk website</u>. Please do familiarise yourself with this guidance.

Shielding for clinically extremely vulnerable (CEV) children.

We know from growing evidence that many children identified at the start of the pandemic as clinically extremely vulnerable (CEV) are not at increased risk of serious outcomes from coronavirus (COVID-19) and children are gradually being removed from the shielding patient list (SPL) as appropriate, following review with a clinician.

Shielding advice has been paused nationally from 31 March. From 1 April, all CEV pupils should attend their school unless they are one of the very small numbers of pupils under pediatric or other specialist care and have been advised by their GP or clinician not to attend. Pupils who live with someone who is CEV should continue to attend school as normal.

Education providers covered by the <u>Temporary Continuity Direction</u> are required to provide remote education to pupils who are unable to attend school on-site because they are complying with government guidance or legislation related to coronavirus (COVID-19).

To help support schools, **Slough Borough Council are hosting Attendance Drop-in online sessions** for Attendance Officers/school staff to attend once a month to give school staff an opportunity to raise any attendance based issues and questions. The Drop-in sessions are not compulsory but will be an informal forum for schools to access advice from the Attendance Service.

News from TVP to parents:

As children begin returning to school and will increasingly be out and about as they travel, a reminder about personal safety and keeping possessions safe. Sadly, aswe get to lighter, and hopefully warmer, evenings, we frequently see a rise in reports of children being robbed or intimidated into handing over items such as bikes and phones. The offenders can often be older children.

Bikes can be expensive but many owners do not keep any details which can assist in recovering them especially if they are being sold on. Keep receipts, and make a note of the bike's make, model and serial number. Take a picture that highlights any damage or any features that might make your bike unique or easily identifiable. Note similar details of your children's mobiles.

To keep them safe -

Encourage your children to use the buddy system – walk and play with friends and classmates.

Teach your children to avoid solitary areas like alleys and parks after dark.

With your child, map out a safe route to the bus stop, school and friend's houses. Where possible keep to well lit streets and paths which are more likely to be covered by CCTV.

Explain the importance of being aware of their surroundings and the people around them especially when they are using their phone in public.

Teach your child that if they are in danger they should not be embarrassed to yell "help! call 999 or to find a safe place or adult.

Secondary 29th April 2021 |23rd September 2021 The **Slough Safeguarding Partnership** seminars concentrate on a specific aspect of safeguarding practice in a multi-agency environment and are intended to support practitioners who need to "refresh" or update their safeguarding training.

For colleagues looking to fulfil their responsibility for Level 3 children's safeguarding, we have developed a number of different 2 hour seminars which can be combined to provide them with their 8 CPD hours. These include:

1. Difficult conversations regarding neglect in children's safeguarding, including the use of the thresholds and new toolkit. The title reflects the skills involved in broaching this subject with parents and also communicating and sharing concerns to partners. The seminars will discuss non-compliance and consent issues as a key component of risk factors in neglect which we have learned from serious case reviews

2. **Coercive Control Awareness** This training will help professionals identify signs and assess risk as well as provide help to victims. It will also incorporate the new legislation to support conviction of coercive and controlling behaviour (CCB).

3. Child Protection Case Conferences in Safeguarding Children To develop professional competencies in the workforce in the application of practice standards around Multi agency contributions to Child Protection Case

4. **Exploitation of Children, Young People and Vulnerable Adults.** Staff or volunteers who need to work with partner agencies in recognising and responding to concerns of exploitation, including Child Exploitation, Criminal Exploitation, Gangs, Modern Slavery and Adult exploitation.

5. Core Groups in Children's Safeguarding

To develop professional competencies in the workforce, in the application of practice standards around Multi agency contributions, to Core Groups.

6. **Multi Agency Risk Tool for Adults who do not access services (MART)** Staff and volunteers who work with adults at risk (including 17 - 25 year olds transitioning from support from Children's Services) who need to use a multi agency approach to provide support when safeguarding support is inappropriate or refused.
