## Updates to sector guidance following the September Review

On Tuesday 14 September, the Cabinet Office published the <u>COVID-19 Response – Autumn and Winter Plan 2021</u>. This guidance set out plans for autumn and winter 2021/22 in England. We have updated our guidance documents to reflect the changes made to the government's response to COVID-19. The following pieces of guidance have been updated to align with the autumn and winter plan:

- Quarantine arrangements for unaccompanied minors joining higher education providers in England

Updates to these pieces of guidance include changes to international travel announced by the Department for Transport and the removal of references to Step 4 of the COVID-19 roadmap.

## What parents and carers need to know about early years providers, schools and colleges during COVID-19

Information for parents and carers about attending schools, nurseries and colleges in 2021; information added on universal vaccinations for 12 to 15 year olds, updated sections on self-isolation, education recovery and guidance for critically extremely vulnerable children and young people to reflect that no under-18s are now considered to be clinically extremely vulnerable and all have been removed from the shielding patient list. Clarified the circumstances in which schools may be advised to reintroduce 'bubbles'.

## What to Expect in the EYFS

DfE has published a new guide for parents, produced by Sheringham Nursery School and Children's Centre. What to Expect in the Early Years Foundation Stage! (formerly 'What to Expect When') guides parents through what to expect with their child's development. It aligns with the new Development Matters to help practitioners engage with parents about their child's development.

## A Celebratory Approach to Working with Children with SEND

DfE has also published a new guide for practitioners, produced by Pen Green Children's Centre - 'A Celebratory Approach to Working with Children with SEND – Giving additional support in the Early Years' (formerly 'A Celebratory Approach to SEND assessment in the Early Years') to help practitioners who may be supporting children who require additional help or children with Special Educational Needs and Disabilities.

## Apply to register as a childminder

Find out when you must apply to register if you want to look after other people's children in your home or someone else's home. Further information on childminder agencies added. This is not a change in law or practice.

#### Childminder agencies: registration and suitability

Guidance for childminder agencies on registering with Ofsted, including the process, fees and requirements. It sets out the legal background and the extent of our regulatory powers. Added guidance for childminders or providers of childcare on domestic premises who want to register with a childminder agency.

#### Apply to register your nursery or other daycare organisation (EYO)

Find out when you must apply to register if you want to set up a nursery, or other daycare organisation for children. Information added on childminder agencies being able to accept registrations for childcare on domestic premises. This is not a change in law or practice.

## **UPDATED PHE DOCUMENT (VERSION 07))**

Please find attached a copy of the new version (07) PHE Outbreak Management Pack. There are a number of changes:

- Section 4.3 Students/staff of close positive COVID contacts are now being advised to undertake a PCR test if they have not been contacted by NHS Test and Trace.
- Removal of advice about contacting T&T hub for staff.
- Template emails updated to advise that inform and advice letters (either produced by LA or HPT)
  can be sent in outbreak situations or at HT discretion.
- Referral form has been updated to include a questions about CEV individuals.

Peter Rowe (Head of Ryvers Primary) has also reported that he contacted the self-isolation hub yesterday on 020 3743 6715 re Test and Trace in the Workplace and they wouldn't accept his referral. He was advised to contact the CV19Notifications drop box at <a href="mailto:CV19Notifications@slough.gov.uk">CV19Notifications@slough.gov.uk</a> So please could you continue with CV19Notifications using the usual pro forma (see above)

#### **COVID VACCINATIONS FOR 12-15 YEAR OLDS**

Whilst I appreciate that this is only relevant to Secondary Schools, you may have queries from parents. There is a new national 119 line now equipped to take queries from the public about 12-15s vaccination programme, so please can you signpost any parents with queries to this number.

There has been a hoax consent form (with NHS logo) for 12-15 year olds circulated to Slough Secondary schools, which the Secondary schools are aware of but if you have any queries around this or experience any suspicious communications yourselves which may be from anti-vaccination groups please contact Heather Cook as below, who can advise.

## Food safety advice on choking hazards in settings

Tragically, a child dies in the UK every month from choking and hundreds more require hospital treatment. It can happen quickly and it can happen to anyone.
