Annex 1: Government childcare support packages for parents



Introduction

Countries around the world are facing rising goods and energy prices, inflation and cost of living pressures. We know people are worried, so the government is offering <u>help for households</u>.

Over a million families in the UK are entitled to some form of government childcare support, but many are missing out because childcare providers in their area haven't signed up to offer the various schemes.

In parallel, many childcare providers are missing out on boosting their businesses by increasing demand as they aren't accessible to families who use government childcare support.

Government Childcare financial support is not limited to just nurseries and childminders, depending on eligibility criteria, this support could help boost business for **breakfast clubs**; **after-schools clubs**; **activity clubs**; **holiday clubs**; **home care workers** and **play schemes** or children up to 11 or 17 if disabled with Tax-Free Childcare and children 0-16 with Universal Credit for Childcare.

With the school holidays approaching, it is more important than ever that parents and carers are able to access the financial aid they qualify for. It can reduce their costs, help them to stay in work, or help them work more hours.

This toolkit contains a step-by-step guide to help you make your services accessible to families who use government childcare support, boosting your business in the process. How you can help

- By making sure you have the correct elements in place for your services to be accessible to families using the different types of government childcare support.
- By advertising the fact that your services are available to parents who are using government childcare support (resources on pages 9-12), boosting your potential client base in the process.
- Reminding families using your services to visit the <u>Childcare Choices</u> website to check what government financial support they could be entitled to.



How to register

As a childcare provider or childminder, we ask that you take the following two steps to make sure families can access government support when using your services:



If you haven't already, register with the relevant regulatory service:

This will enable parents and carers to access Universal Credit for childcare and 30 hours (or equivalent if offered) support when using your services.

If you're in England: Signing up to Ofsted's Voluntary Childcare Register if you're a childcare provider (guide on page 7), or if you're a childminder, registering with Ofsted or with a Childminder Agency.

If you're in Scotland: Signing up to the <u>The Care Inspectorate's Care Service register</u> if you're a childcare provider, or if you're a childminder, registering with <u>The Care Inspectorate's Childminder register</u>.

If you're in Wales: Signing up to the <u>Care and Social Services Inspectorate for Wales (CSSIW) Childcare and Play Service register</u> if you're a childcare provider or childminder.

If you're in Northern Ireland: Childcare providers (looking after children for more than 2 hours per day, for reward) are legally required to be registered with your local Health and Social Care Trust, Early Years Team. Contact your local Early Years Team for guidance or to register your interest: Find my local Early Years Team.

2 Check that you have activated your Tax-Free Childcare account (guide on page 8). This will enable parents and carers to access Tax-Free Childcare support when using your services.



Ofsted registration- Eligibility criteria *England only

Find more information on eligibility

In England, most childcare providers who look after children aged under eight will already be registered with Ofsted or a childminder agency.

However, those providing care to children aged eight or over, or who have an exemption from compulsory registration (e.g. activity providers, some home-based carers), will need to join the voluntary part of the <u>Ofsted General Childcare register</u> so that parents can use Universal Credit or Tax-Free Childcare when paying for their services.

Permitting they **provide care to the same child for two or more hours a day**, a large variety of childcare providers are eligible to register with Ofsted. Such as:

Guide to Ofsted Voluntary Childcare registration *England only

As a childcare provider registered with a regulator, you could accept payments from families using or Universal Credit or Tax-Free Childcare. If you are in England, this means joining the voluntary part of the <u>Ofsted General Childcare register</u>.

Before you start, you will need:

- A specific type of criminal record (Disclosure and Barring Service- DBS) check. <u>Please read this guidance on</u> <u>what DBS check you need</u> - having the wrong type will delay your registration. Ofsted also recommends joining the <u>DBS Update Service</u> to keep your details up to date.
- To ensure that at least one person caring for the children on the premises has a paediatric first-aid certificate and training in the <u>common core skills</u> or at least a <u>level 2</u> <u>childcare qualification</u>. These do not have to be held by the same person, but there must always be staff qualified with these on the premises when children are being cared for.

Other people connected to the registration:

You will also need to read our <u>dedicated guidance</u> to know who else connected to your daycare will need to apply to Ofsted.

Lived abroad:

If you have lived abroad in the last 5 years, you may need a <u>certificate of good conduct or other evidence</u> from the relevant embassy.

How much it costs:

It usually costs £114 to apply to register with Ofsted. The registration fee is not refundable. You will need to pay your registration fee each year. Find out about <u>other costs and</u> <u>renewal fees</u>.





Once you are Ofsted registered, you are automatically able to accept payments from parents who are using Universal Credit childcare support. Please see **Annex 1** for more information on how parents become eligible for Universal Credit childcare support.



Guide to activating your Tax-Free Childcare account

Once registered with a regulator in the UK, you can boost your business and help reduce cost for working families by activating your Tax-Free Childcare (TFC) account. Setting it up is free and only takes around ten minutes.

After the registration process with the regulator has been completed, you should receive an invitation letter containing your unique 11 digit user ID, along with instructions on how to sign-up online to TFC. If you are already registered and haven't received your invitation letter, you should contact the <u>Childcare Service helpline</u>.

Activating your TFC account:

You'll find everything you need on the GOV.UK Tax-Free Childcare if you're a childcare provider page.

To sign up you'll need your:

- unique 11-digit user ID
- business bank account details, so you can receive payments
- business postcode (the one registered with your regulator)

Once you've signed up, you can:

- Accept Tax-Free Childcare payments and get a childcare provider account which you can use to keep your details up to date
- Manage payments online 24/7 (using your provider account)
- Promote the financial benefits to your customers
- Still accept payments from parents using childcare vouchers and other methods





Annex 1: Childcare support packages 1/2

The eligibility criteria of the different forms of government childcare support packages that parents can access are as follows:

Tax – Free Childcare	Universal Credit support
 For working families, including the self-employed, in the UK 	 For working families claiming Universal Credit, in England, Scotland, Northern Ireland and Wales
• Earning under £100k and at least £152 per week (equal	With children under 17*
to 16 hours at the National Minimum or Living Wage) each	Up to 85% of eligible childcare costs
Who aren't receiving Tax Credits, Universal Credit or	Who aren't receiving Tax-Free Childcare
 With children aged 0-11 (or 0-17 if disabled) 	Can be accessed through registered providers or childminders.
 For every £8 they pay into an online account, the government will add an extra £2, up to £2,000 per child per year (or up to £4,000 per child if disabled) 	
Can be accessed through your registered providers and childminders who have activated their Tax-Free Childcare accounts.	

Annex 1: Childcare support packages 2/2

15 hours free childcare-Age 2

- For families **in England**, receiving some forms of support
- With 2-year-old children
- 15 hours of free childcare or early education for 38 weeks
- A total of **570 hours per year**, that they can use flexibly with one or more childcare provider
- By already being registered, all early years settings are set-up to offer 15 hours free childcare

15 hours free childcare-Ages 3 & 4

- For all families in England with 3 and 4-year-old children
- **15 hours of free childcare** or early education for **38 weeks**
- A total of **570 hours per year**, that they can use flexibly with one or more childcare provider
- By already being registered, all early years settings are set-up to offer 15 hours free childcare

30 hours free childcare

- For working families in England with 3 and 4-year-old children
- **30 hours of free childcare** or early education for **38 weeks**
- A total of 1,140 hours per year, that they can use flexibly with one or more childcare provider
- By already being registered, all early years settings are set-up to offer 30 hours free childcare
